Ibnsina Pharma agreed with Novartis to distribute 10+ stock-keeping units of Alcon products – a division of Novartis - the global leader in eye care products. Ibnsina Pharma expands its product portfolio and ensures sustainable organic growth of its core business.

Ibnsina Pharma (ISPH.CA on the Egyptian Stock Exchange), Egypt's fastest-growing and second-largest pharmaceutical distributor, has agreed with Novartis to distribute 10+ stock-keeping units of Alcon products – a division of Novartis - the global leader in eye care products in Egypt.

Previously reliant exclusively on one private distribution company and most recently on three other distributors including ibnsina Pharma, Alcon will join a group of over 350 domestic and international suppliers who rely on Ibnsina Pharma to distribute their products to over 42,000 pharmacies, retail chains, wholesalers, private hospitals across Egypt.

"We are excited by this new opportunity to distribute Alcon's eye care products across Egypt," said Omar Abdel Gawad, Ibnsina Pharma Co-CEO. "Alcon products distribution is another prove that exclusivity is dying in the pharma market. As the fastest growing distributor in Egypt, suppliers who want to grow at or above the market growth rate, have to contract with ibnsina Pharma to achieve their targets. The distribution of Alcon products will begin this month and is expected to contribute approximately EGP 125 million to our top-line during their first year of implementation."

"At Ibnsina Pharma, our commitment to maintaining high operating standards and serving as a one-stop shop providing storage, distribution and value-added marketing services has allowed us to become highly successful in the market and a distributor of choice for many suppliers from both Egypt and abroad." said Mahmoud Abdel Gawad, Ibnsina Pharma CO-CEO. Alcon sales in Egypt reached around EGP 450 million in 2018 while ibnsina market share in the total pharma market (retail pharmacies, tenders, hospitals and wholesale) reached 20%. Currently ibnsina pharma has a total of 59 operational sites and fleet of around 650 vehicles across the country in line with the 5 years expansion plan to invest EGP 700 million.
