Heliopolis Housing is about to sign a contract to sell 243 feddan in New Heliopiolis for EGP c.1.7 billion

Heliopolis Housing (HELI.CA) BoD approved a planned contract to sell a vacant land plot of 243 feddan located in the 20th district in New Heliopolis City. The area is assigned for integrated services residential housing. The total value of the contract is EGP c.1.735 billion (EGP1,700/sqm – excluding utilities connecting costs). The payment schedule will be as follows:

- 20% of land price when signing the contact. (Expected to be within the coming few days).
- 80% of the land price to be paid over 16 equal quarterly installments without interest.

The deal, with its cash proceeds, will contribute accelerating the development pace of New Heliopolis in line with the company's strategy to transform New Heliopolis into an integrated city.
